1 REGISTER OF APPLICABLE LEGISLATION

Legislation	Description
General Data Protection Regulation 2016/679 (GDPR)	This Regulation provides a right of access by living individuals to personal data held about them by any person, subject to any exemption, which may apply. It imposes responsibilities on those who process personal data in addition to those who control data. The Regulation requires compliance with the data protection Principles and emphasises Data Protection accountability.

Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in a Data Controller's possession or which they are likely to come into possession of. The processing of personal data is governed by *The Data Protection Act 1998* and will be superseded on 25 May 2018 by *the General Data Protection Regulation 2016/679 (GDPR)*. This Privacy Notice is intended for use under the GDPR.

Who are we?

BARRACHD are a Data Controller and processor of your personal data in respect of its collection and use, once submitted by you through this website. BARRACHD understands the importance of protecting personal data and as such we afford your data with the care you would expect.

How do we collect your personal data?

This Privacy Notice is solely intended for use in the collection of the data submitted by you with your consent. By submitting your personal information through this website, you shall be consenting to it being processed in the manner described below.

How do we process your personal data?

BARRACHD complies with its Data Protection obligations under the *GDPR* by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical and organisational measures are in place to safeguard personal data.

At BARRACHD we use your personal data for the following purposes: -

1. to let you know about special offers, new services and service related notices.
2. to get in touch with you to invite you to webinars, new solution launches and user groups.
3. to personalise your session on our website to better fit your interests by offering relevant individually tailored content.

Why we need your data.

At BARRACHD we aim to fulfil our Data Privacy obligations under the GDPR and as such we request only the minimum amount of personal data from you to allow us to perform the related tasks.

Sharing your personal data.

Your personal data will be treated as CONFIDENTIAL and we will not disclose it to anyone outside of our organisation. In connection with any application, request or enquiry you make, your information will be passed directly to the relevant department within Barrachd and nowhere else.

How long do we keep your personal data?

We keep your personal data for no longer than is reasonably necessary. Personal data will be subject to the Data Retention Policies of Capita.

Your rights and your personal data.

Unless subject to an exemption [*under the GDPR*], you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which we hold about you;
- The right to request that BARRACHD corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for BARRACHD to retain such data;
- The right to request that the Data Controller (BARRACHD) provides the data subject with his/her personal data and where possible, to transmit that data directly to another data controller.
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to lodge a complaint with the Information Commissioner's Office.
